FIRST DAY Hall of the House of Representatives, Columbus, Ohio Monday, January 6, 2025, 2:00 o'clock p.m.

This being the day designated by the Constitution of the State of Ohio for the meeting of the General Assembly in regular session, the members-elect of the House of Representatives assembled in the Hall of the Representatives at 2:00 o'clock p.m. and were called to order by the Honorable Jason Stephens, Speaker of the House of Representatives, One Hundred Thirty-Fifth General Assembly.

The One Hundred Thirty-Sixth General Assembly rose for the opening prayer, offered by Representative-elect Johnathan Newman.

The colors were presented by the Allen County Sheriff's Office, and the National Anthem was led by Representative Melanie Miller, followed by the Pledge of Allegiance to the Flag.

Pursuant to Section 101.11 of the Ohio Revised Code, the Chair appointed Representative John to serve as clerk pro tempore.

Representative Manning moved that the oaths of office and certificates of election of absent members-elect be accepted and that the oaths of office be spread upon the pages of the journal.

The motion was agreed to without objection.

The Chair then called to order the House of Representatives of the One Hundred Thirty-Sixth General Assembly of the State of Ohio.

Speaker Stephens addressed the House as follows:

Good Afternoon! And Welcome to the People's House.

As the Speaker of the previous General Assembly, it is my duty and honor to preside over the beginning of our proceedings here today in this, the first session of the 136th General Assembly.

The meeting of the General Assembly of this great State of Ohio is a special occasion, and meeting here in this place, the Chamber of the Ohio House of Representatives, is always a time to remember why we are here and whom we

serve

This chamber has become affectionately known as "The People's House," and today I would like to take just a few minutes and talk about the people who make this institution so special.

First, I would like to talk about our representatives. For some of you, this may be the first time that you have ever served as an elected official. For others, this may be the first time you have served at the state level. While others of us may be entering another term, and still some of you once served here and you liked it so much, that you have found your way back to the House to serve in this 136th General Assembly.

Regardless of how long (or how short) any of us has had the privilege to serve as a State Representative here in Ohio, it is truly an honor. I encourage each of us to get to know one another over these next two years. Find what makes other reps tick. What are their concerns? How did they get here? What is their favorite hobby or ball team?

Whatever the common thread may be, I encourage us all to get to know each other. Just like back home in your districts, it will help you here to be able to have honest discussions with people you know (even though you may not agree with them). Some days it is easier than others, but the goal is to get to know your colleagues as people. It will make your job as a Representative much easier.

Second, the people who really make this place run are the House Staff. Whether it is Senior Staff, Policy Staff, the Comms Team, the Clerk's Office, the Administration, IT, LSC, Legislative Aides, or the pages, each and every staffer who works for the Ohio House of Representatives serves a critical role to make sure this Institution works to serve the people of Ohio.

Again, I encourage us all to treat our staff with professionalism and dignity. They are, in fact, the ones who ultimately make us look good.

In fact, my first Legislative Aide, Rachel Ehresman is here today, and I would like to give her a special shout out. Thank you to all of our staffers who are dedicated to serving the people of Ohio.

Now, of utmost importance to all of us are the people who probably sacrifice the most for us to be here--our families and loved ones. They will be the ones who sacrifice while the Representatives serve. Whether it is a meeting that goes later than expected, travel plans interrupted, or just an untimely phone call, our families sacrifice a lot for us to be able to be here.

I would like to recognize my wife, Juli, who is here today in the gallery. I'm sure you all have family members here today. Let's take time to recognize all of the family members of Representatives who are here today.

It is an honor to serve, and all the people I have mentioned so far play a crucial role in some form or fashion in helping us as Representatives to get our job done.

And what exactly is that job of State Representative? Our job is to serve the PEOPLE-The PEOPLE of our Districts and the PEOPLE of Ohio.

These people who sent us here to this town, whether they all voted for us to be here or not, are counting on all of us to work hard to understand the issues and make tough decisions that will ultimately improve their lives.

People like Herb, who is a retired phone worker. Herb wants to make sure his family and grandkids can live closer to home here in Ohio, and that the local Community Center is able to be a place of pride for people to gather.

People like Eileen, who at one time worked as a manufacturing supervisor, but is now in a nursing home and needs constant care and attention. Her health is not what it was. Her husband is gone, but her dignity certainly is not.

People like Michael and Matt, who lost their father last year and own a family business that employs hundreds of people. They worry about taxes being too high, having enough qualified workers, and regulations being too burdensome, among many other things. They just want to run their business in a safe and profitable manner.

People like Phoebe, who is a retired teacher of over 30 years who is living on her pension and trying to make sure she can pay her property taxes to keep the home she raised her kids in and has lived in all her adult life.

People like Edie, who is a very bright middle school student who is trying to learn enough to pass her standardized tests and deal with all the pressures of social media and being a pre-teen in 2025.

People like Nathan, who is a husband and a father of two rambunctious elementary school-aged boys who works his normal job and serves our country in the National Guard. Not to mention his wife, Amber who tries to wrangle and keep up with those boys when he is away.

I could go on and on, and even though you may not know Herb, or Eileen, Michael or Matt, or Phoebe, Edie, Nathan or Amber, but I guarantee that you certainly know someone like them.

We represent the nearly 12 million People of Ohio. Each one with their own individual story. These are the people we serve in this body.

These individuals are the people of Ohio who are counting on us, as their representatives, to strive to make each and every unique corner of Ohio better off in the future than it is today.

Regardless of where we are from...whether it be the bountiful rural plains of our farmlands, or whether it be the economic hubs of one of our great cities, whether it be the nicest small town or the swankiest suburb, whether it be along the great Lake Erie or the grand Ohio River, or even if it's somewhere in the hills of Appalachia in a place as small as it sounds like Kitts Hill...We Are Ohio!

The PEOPLE of Ohio are counting on us. They are counting on us to work with one another. They are counting on us to work to keep this institution strong.

But most importantly the People of Ohio are counting on us to work to make their lives better. May we all strive to do just that in this 136th General Assembly. Now let's get on with it and get to work.

Message from the Senate

Mr. Speaker:

I am directed to inform the House of Representatives that the Senate is now in session and ready for the transaction of business.

The Speaker then addressed the House as follows:

Members of the House, before we adjourn, I did need to take this opportunity to thank a few people and just make some brief remarks, because I think it's still snowing and your families are here and there are things to be done. I also, like Speaker Stephens, want to thank the staff, especially the Clerk's Office, who put this day together, and all of the other things, not just this session, but throughout the state capital. It's been wonderful.

I wanted to thank my family, Sheryl, in fact, we have been married 40 years. That's remarkable for her. I tell you, 45 years ago, standing on the green outside the football stadium at Notre Dame, she said to me, I think you have potential, and then like last week, she just said the same thing to me. So, she still thinks I have potential and so I'm looking forward to the next 30 to 40. We'll see what happens. Also, my son Sam, kind of looking like a security guard is sitting right over there. When Sam was four years old, I was sworn in as president of the Lima City Council, and in the middle of the meeting, he

stood up on a chair and yelled, "Hi, Daddy!" Last month my daughters gave a very nice speech over in the atrium about me, and I think Sam thought he was going to get to speak today, but you're not, so thanks for coming anyway.

I do have to tell this story. So my dad was a United States Marine. He got a free trip to Korea in 1952, in combat for a year and when he came back, he was a recruiting officer. They lived in Sidney, Ohio, my mom and dad, she was pregnant with my oldest brother, Larry, and the Marine Corps asked him to sign up for another three years because they thought he was doing a great job as a recruiting officer. And he indicated he was all done with the Marines at that point, and wanted to move on. And the Marine Corps doesn't like it when you say no to them. So, they transferred him from Sidney to Columbus, Ohio. Without any provisions for housing or anything. My mom, six months pregnant, had to go live with his parents in Dayton, Ohio, and my dad lived in what was then the Knights of Columbus over on Fifth Street. The building is still there. And he would walk down the street to the old post office building right across the street, which is now a law office, and when I was in the House before, I could look out the window and see that building and think about him. And things are, believe it or not, a lot easier for us today than they were then

So, I think if we all think about the people who came before us, and the shoulders that we stand on. We're a lot... gratuity, and being grateful makes our days a lot easier. It is when I get to moments like this, I think about, well, I have some interesting words to say, but, then I always fall back on the fact that there are smarter people who came along long before us. One of them was a fellow who wrote a book about James Madison, and I want to read this to you because this might be the only time I have everyone's attention at the same time, but this author said of James Madison:

"Madison's trademark talent was superior preparation. He seldom missed a session and always seemed to have more facts on his fingertips than anyone else. Amid the flamboyant orators of the Virginia dynasty, he was almost invisible and wholly unthreatening, but the acknowledged master of the inoffensive argument, that so often proved decisive. He seemed so innocuous, even gentle, that it was impossible to unleash one's full fury against him without seeming a belligerent fool. His style, in effect, was not to have one. As a result, a Madisonian argument lacked all the emotional affectations, but struck with the force of pure thought, embedded in overwhelming amounts of evidence."

And I've tried to do that. I invite many of you to try to do that also. We do need flamboyance, and so with that, I turn to, of course Abraham Lincoln, the great orator, who similarly said, and you'll recognize this:

"Neither let us be slandered for our duty by false accusations against us,

nor frighten from it by menaces of destruction to the government or of dangers to ourselves. Let us have faith that right makes might. And in that faith, let us to the end dare to do our duty as we understand it."

So a couple of remarks from folks a lot smarter than me, but it might be helpful. Eighteen years ago, I was sworn in as a state representative in these very chambers, and although I had served on city council in Lima for 15 years and I was practicing law for 20. I didn't know very much about what I was doing. But I did have one advantage that most of you don't have and that was... Alice..., that I had Bill Batchelder as a friend and a mentor. I had a couple of interesting Batch stories. One of which was when I sat in the chair that Gayle Manning is sitting in, every once in a while he would stand up and he'd give me one of these, and I'd come up and I'd sit in this very chair and he'd give me an array of instructions about this member, that member, and etc., etc., and I have to tell you, sometimes, I was bewildered as to exactly what I was supposed to do, but, after I had a day or week or even years to think about it, it dawned on me, why it was that Bill was telling me what he was telling me, and that's why I asked Alice to come and swear me in today. Also, that's why I'm going to use Bill Batchelder's gavel with his name on it that he gave me ten years ago when conducting business here in the House. But I'm going to miss Bill, as we all do, who knew him, but I think that I'm going to be a better Speaker because of him.

While, some of you may be saying, well, you're no Batchelder, and you're no Madison, and you're no Lincoln, and that is all very true, but I can commit to a few things up here for you. First, I am committed to a professional, fact-based and thorough process in our analysis of the law and the bills that come before us. Our goal should be clarity and resolution. If we can resolve things, if we can make decisions and move on, that is one sign of success, and that's what I'm committed to.

To all ninety-eight of my fellow members, if there's something that I can do for you or the Speaker's Office can do for you, and it's something that I fairly feel that I will do, I will. Don't hesitate to ask. And if it may be that the answer is I don't think I can do that, but I can do this. But that is something that I think is incumbent upon the Speaker of the House that is a servant to the ninety-eight members. This is a pretty small club, in a group of eleven million people in the state of Ohio, and we get criticized often because we tend to work things out and then we get criticized because we don't work things out, but we're the only ones who are here making the votes. We're the only ones that we know what the job is. We are going to have many tears and smiles over the next two years. If we do this right, we'll have more smiles than tears. This is all metaphorical, of course, although it may actually happen. But I want to make sure that each of you know that my attempt is going to be to make sure that everyone is fairly heard, and ultimately we move forward on an effective professional decision making process.

Deacon Michael Huffman of the Saint Margaret of York Parish in Loveland Ohio, Archdiocese of Cincinnati, offered a benediction.
