INTRODUCTION OF BILLS

The following bills were introduced:

To amend sections 5747.08 and 5747.98 and to enact section 5747.87 of the Revised Code to authorize a nonrefundable income tax credit for having a dog spayed or neutered or for completing a dog training course.

H. B. No. 243 - Representatives Thomas, C., Brewer. Cosponsors: Representatives Brennan, Brownlee, Grim, Lawson-Rowe, Rader, Rogers, Russo, Upchurch, White, E.

To enact section 5.212 of the Revised Code to designate April 5th as "Dolores Huerta and Cesar Chavez Ohio Community Service Day."

H. B. No. 244 - Representatives Grim, Piccolantonio. Cosponsors: Representatives Synenberg, Rader, McNally, Brennan, Lett, Upchurch, Brownlee, Baker, Sims, Cockley, Robinson, White, E., Rogers, Somani, Russo.

To enact section 5.56 of the Revised Code to designate March as Women's History Month.

H. B. No. 245 - Representatives Somani, Grim. Cosponsors: Representatives Piccolantonio, Upchurch, Brennan, Cockley, Brownlee, Russo, McNally.

To amend sections 3125.18, 5101.35, 5101.80, 5101.801, 5101.804, 5101.805, and 5153.16 and to amend, for the purpose of adopting a new section number as indicated in parentheses, section 5101.804 (5101.91) of the Revised Code regarding services provided through the Ohio parenting and pregnancy program.
