**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bills were introduced and considered for the first time:

**S. B. No. 232** - Senator Weinstein.

To amend sections 956.01, 956.031, and 956.10 of the Revised Code to revise the law governing high volume dog breeders.

**S. B. No. 233** - Senator Hicks-Hudson.

To create the Ohio Local and Organic Food and Farm Task Force.

**S. B. No. 234** - Senators Smith, Craig.

Cosponsors: Senators Antonio, DeMora, Hicks-Hudson, Liston, Weinstein.

To amend sections 4111.02, 4111.05, 4111.09, and 4111.14 and to repeal section 4111.07 of the Revised Code to increase the state minimum wage.

**S. B. No. 235** - Senators Smith, Craig.

Cosponsors: Senators Antonio, DeMora, Hicks-Hudson, Weinstein.

To amend sections 2923.13 and 2923.14 and to enact section 2923.133 of the Revised Code to prohibit certain conduct regarding trigger cranks, bumpfire devices, and other items that accelerate a semi-automatic firearm's rate of fire but do not convert it into an automatic firearm.
