# FIFTEENTH DAY Senate Chamber, Columbus, Ohio Wednesday, February 19, 2025, 1:30 p.m.

The Senate met pursuant to adjournment.

Prayer was offered by Rev. Dr. Stephen Lowell Swisher, St. John's United Church of Christ in Newark, Ohio, followed by the Pledge of Allegiance to the Flag.

The journal of the last legislative day was read and approved.

The following guests were recognized by the Senate prior to the commencement of business:

Senator Craig requested a moment of silence to honor former Columbus Chief of Police, James Jackson, who passed away on January 2nd. He was the first black Columbus police chief and the longest serving police chief in the history of the Columbus Division of Police. He dedicated fifty-one years to the Columbus Division of Police and served as chief for nineteen years.

Senator Ingram recognized outstanding Ohioan, Toni Morrison, and Toni Morrison Day on February 18th.

Senator Patton recognized former Congressman and current Youngstown University President, Bill Johnson, on his visit to the Statehouse.

Senator Lang recognized Bladen Gilbert and Anthoni Rossi on their visit to the Statehouse.

Senator Reineke recognized members of the Farm Bureau on their visit to the Statehouse.
